UPDATES FROM THE FARM SERVICE AGENCY

The COC meetings are held on the second Wednesday of each month at 10:00AM at the Vanceburg USDA Service Center. The Regular Session of the meeting is open to the public. The Executive Session, where we discuss individual producer information, is closed to the public.

NEW PROGRAMS RELEASED – EMERGENCY RELIEF PROGRAM (ERP) PHASE 2 AND PANDEMIC ASSISTANCE REVENUE PROGRAM (PARP)

There are two new programs that FSA has released information on just this week. We will refer to them as ERP Phase 2 and PARP. Both of these programs are revenue-based. ERP Phase 2 focuses solely on crops, however, PARP focuses on crops AND LIVESTOCK. In short, if any of your crop or livestock producers suffered at least a 15% loss in gross revenue in calendar year 2020 when comparing to either year 2018 or 2019 (whichever loss is greater), they need to contact us and sign up. Producers will need to utilize their Schedule F to determine these losses. We've been told these are the final pandemic programs we will administer.

The sign-up period for both ERP Phase 2 and PARP is January 23 – June 2, 2023. We appreciate the large window to try to reach as many producers as we can.

CHANGES TO INSURANCE AND DISASTER PROGRAMS

FSA has released some changes to some of our regular programs. For our Non-insured Crop Disaster Program (NAP), which is an insurance option that can provide a payment to crops lost due to a natural disaster, every producer that is in our FSA system that is considered "Socially Disadvantaged" can get automatic coverage for free. Socially Disadvantaged farmers are considered groups that have been subject to racial, ethnic, or gender prejudice because of their identity—racial minorities, Hispanics, and women. The free coverage can also apply to limited resource farmers, beginning farmers, and veterans (must have first obtained status as a veteran during the most recent 10-year period). NAP can cover hay losses, so if you have producers that may fit these categories, please send them our way. It'll save them \$325 a year and help them out in the event of a natural disaster.

REPORTING LIVESTOCK LOST DURING THE EXTREME TEMPERATURES IN DECEMBER

Did You Experience Livestock Losses During the Cold Temperatures on December 23-24?

Contact the Vanceburg USDA Service Center, (606) 769-3866, to report any livestock deaths (adult or newborn) due to the extreme cold temperatures on December 23-24. Your losses may be eligible for payment through the Livestock Indemnity Program (LIP).

Frost Seeding at a Glance

- ✓ Legumes are an essential part of sustainable grassland ecosystems.
- ✓ Overseeding may be required to maintain and thicken stands.
- ✓ Frost seeding is the simplest method for reintroducing clover back into pastures.
- ✓ Control broadleaf weeds prior to frost seeding.
- ✓ Soil test and apply any needed lime or fertilizer before frost seeding.
- ✓ Suppress the existing sod and reduce residue with hard grazing in the fall and winter.
- ✓ Choose well adapted varieties of red and white clover using the UK forage variety testing data.
- ✓ Calibrate seeder and check spread pattern.
- ✓ Broadcast 6-8 lb/A of red clover and 1-2 lb/A of white clover that has been inoculated in February or early March.
- ✓ Control post seeding competition by grazing pastures until clover seedlings become tall enough to be grazed off
- ✓ Put pasture back into rotation once seedlings reach a height of 6-8 inches.


